Avoid Giving a Recorded Statement

In any insurance claim, someone will have to speak to the negligent driver's insurance company. Under no circumstances should you give them a recorded statement when they ask you to do so. You have absolutely no legal obligation to do this and it can only end up hurting your claim later on.



Seek Medical Help Immediately

After an accident, if you're hurt it's important to seek medical treatment right away. If you're injured but you wait to see a doctor, this creates a "gap" between the accident and your treatment, and the insurance companies will use this gap to argue that you're "not that hurt."
